PHOTOGRAPHER'S AGREEMENT

am the photographer and owner of the photograph(s) uploaded to your website. I hereby grant Crossroads Trading Co., Inc. and its affiliates, assignees and licensees (collectively, "CTC"), if I am a first, second, third or honorable mention prize winner in the contest (a "Prize Winner"), an exclusive right to publish, use, distribute, reproduce, modify, and publicly display the photograph submitted by me (the "Photograph") and to create derivative works from the Photograph for a period of five years from the date of the announcement of the prize winners ("License Term") in any medium now or hereafter known, including, without limitation, on-line or in print, without any compensation to me (other than a prize). I acknowledge that CTC will have no obligation to credit me, but if CTC elects to do so, I agree that CTC has the right to provide my name, city, and state of residence. Subject to the rights granted to CTC, I will retain all copyrights and other rights to use of the Photograph after the expiration of the License Term, but I agree not to use the Photograph in any respect during the License Term.

I warrant that that the Photograph is my original work created solely by me and does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity, or any other rights of any third party, and that my participation in this contest does not violate any agreement between me and any third party. Upon the request of CTC, I agree to provide, within seven days, any of the following signed releases or licenses, each in a form approved by CTC in its sole discretion: a release from all persons, or their parents or legal guardians in the case of minors, who appear in the Photograph, and/or from the owner of any material that appears in the Photograph; and a license from the copyright owner of any artwork or other copyrighted material that appears in the Photograph and/or the owner of any private property that appears in the Photograph. I agree that if CTC advises that I am a potential Prize Winner, I shall provide CTC, as a condition of being a Prize Winner, any and all releases, licenses, liability waivers, and certifications requested by CTC.

This Agreement must be signed by the person submitting the Photograph unless the person is a minor in his or her jurisdiction of residence (less than 18 years of age in California), in which case this Agreement must be signed by a parent or legal guardian of such person.

5. Photographs that are not available in the specified high resolution format, do not have signed release forms, or are submitted after this date can not be considered in the contest.
